As you can see from the attached email I sent to your department on May 2, 2005, I was shocked to see my corporation on your website as "Admin Dissolution for Annual Report". I was told that I need to file a reinstatement application, send filing fees and submit a written request for waiver of the \$600.00 reinstatement fee.

In 2002, I did not get the necessary form from your department and wrote two letters to your department (thank goodness I kept that correspondence and yours) and I have attached the paperwork I received from your department to straighten out that mess. Unfortunately, my memory is not as good as it used to be and the year after I did not get the form and did not remember to ask. This problem all seems to fall back on my change of address I put in with your department in 2001. This form is attached and shows my mailing address as P. O. Box 1797, Trenton, Florida 32693. I believe someone in your department must be sending the forms to my street address which was required by your department in the block labeled "P. O. Box is Not Acceptable". I have no street mailbox due to my mail being stolen - I removed the mailbox. The ONLY way I can get the form is it being mailed to my post office box. I hope there is enough documentation attached that proves that this is an ongoing problem that needs to be resolved, because although I remembered to ask for the form once because I did not receive it, this time I didn't remember until I was looking on your website. I have done very limited amount of work on this corporation in the last 5 years (and have no income) due to it not being my primary job. I don't even have the cash in it necessary to pay the \$600 fee.

I have attached my check for \$300.00 and hope this is acceptable payment.
