The name of the corporation is: **PATIO MAN, INC.**

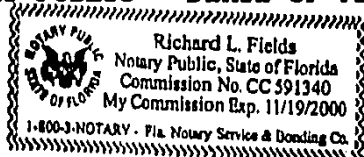
