ARTICLE I - NAME

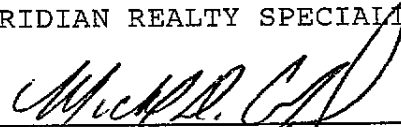
Change in the name of the Corporation:
