ADLIN, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE - NAME AND ADDRESS

The name of the Corporation is Adlin, Inc. Its business location shall be 159 Carolwood Drive, Fern Park, Florida 32730 and its mailing address is P.O. Box 300495, Fern Park, Florida 32730.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
