

**ARTICLES OF INCORPORATION
OF
FIRE PROTECTION DESIGNS, INC.**

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I. CORPORATE NAME

The name of this corporation shall be **FIRE PROTECTION DESIGNS, INC.**

ARTICLE II. INITIAL PRINCIPAL OFFICE

The street address of the initial principal office shall be 10100 A. North Palafox Hwy., Pensacola, Florida 32514. The Board of directors from time to time may move the principal office to any other address in the State of Florida. The mailing address of the corporation shall be 10100 A. North Palafox Hwy., Pensacola, Florida 32514.

ARTICLE III. CAPITAL STOCK

The total authorized capital stock of the corporation shall be 1000 shares of common stock having no par value. No preemptive rights are to be granted to shareholders.

ARTICLE IV. REGISTERED AGENT AND INITIAL REGISTERED OFFICE

The street address of the initial registered office of this corporation shall be 504 N. Baylen Street, Pensacola, Florida 32501, and the initial registered agent at such address shall be John Glassman, Esquire. The board of directors from time to time

may move the registered office to any other address in the State of Florida.

ARTICLE V. INCORPORATOR

The name and street address of the person signing these Articles of Incorporation as the incorporator is Larry Pugh, 10100 A. North Palafox Hwy., Pensacola, Florida 32514.

ARTICLE VI. BOARD OF DIRECTORS

This corporation shall have two (2) directors initially. The number of directors may be increased or diminished from time to time by by-laws adopted by the stockholders, but shall never be less than one (1).

ARTICLE VII. INITIAL DIRECTORS

ARTICLE VIII. NATURE OF BUSINESS AND POWERS

The nature of the business to be transacted and carried on by the corporation is to engage in the design of fire protection systems, and for any other lawful act, activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IX. TERMS OF EXISTENCE

This corporation shall have perpetual existence, commencing upon the filing of these Articles.


ARTICLE X. OFFICERS

The executive officers of this corporation shall be a president, a vice president, a secretary, and a treasurer. Any person may hold two or more offices. The corporation may also have such other officers and agents as may be deemed necessary and all such officers and agents shall be chosen in such manner, hold their offices for such terms, and have such powers and duties as may be prescribed by the by-laws or determined by resolution of the Board of Directors not inconsistent with the by-laws.

ARTICLE XI. AMENDMENT

The corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by law, and all rights and powers conferred herein upon stockholders, directors and officers are subject to this reserve power.


