Upon a duly made and seconded motion, a majority of the Shareholders of Quick Copier Service, Inc. voted to adopt the following resolution:

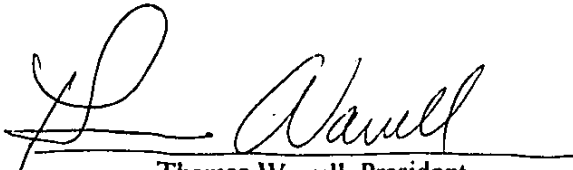
RESOLVED, that Tim Shellabarger is hereby removed from his office as Secretary of this Corporation effective immediately.
