ARTICLES OF INCORPORATION

PHYSICIANS BUILDING DEVELOPMENT CORPORATION

ARTICLE I - NAME

The name of this corporation is PHYSICIANS BUILDING DEVELOPMENT CORPORATION located at 930 South Harbor City Blvd., Melbourne, FL 32901.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

ARTICLE XIII - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XIV - I.R.C. SECTION 1244 STOCK

It is the intent of the Incorporator to qualify the shares issued hereunder as "Section 1244 Stock" pursuant to Section 1244 of the Internal Revenue Code of 1986.
