# Articles of Incorporation of RICHVIEW GROUP, INC.



The undersigned, for the purpose of forming a corporation under the provisions of Chapter 60 of the Florida Statutes, adopts the following Articles of Incorporation:

#### **ARTICLE 1**

The name and initial address of this corporation shall be RICHVIEW GROUP, INC., 724 NW 57th Street, Fort Lauderdale, FL 33309.

#### **ARTICLE II**

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.
