NAME AND ADDRESS

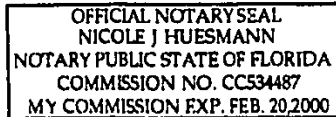



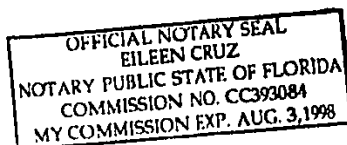
