ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, a natural person, hereby forms this corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is Greens Condition, Inc.

ARTICLE II

ADDRESS

The street address of the corporation's initial principal office is 12235 Augusta Woods Circle, Orlando, Florida 32824.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock. Each share shall have a par value of \$.10 per share.

ARTICLE IV

NATURE OF BUSINESS

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida or of any other state, county, territory or nation.

ARTICLE V

SPECIAL PROVISIONS

The stock of this corporation is intended to qualify under the requirements of Section 1244 of the Internal Revenue Code and the regulations issued thereunder. Such actions as may be necessary shall be deemed to have been taken by the appropriate officers to accomplish compliance.

ARTICLE VI

ARTICLE VII

TERM OF EXISTENCE

The corporation shall exist perpetually.

ARTICLE VIII

The foregoing right of indemnification shall be inclusive of any other rights to which any director, shareholder or officer may be entitled as a matter of law.

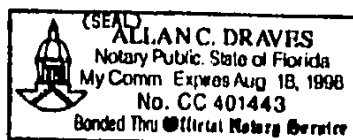


