
This letter is to inform you that I have resigned as any Officer, Director, or Employee of Sunshine Casualty Insurance, Inc. effective 4-4-2001.

Dear Mr. Sabo,

Per the advice of my attorney, I am now, effective immediately, rescinding the purchase of all shares of stock in Sunshine Casualty Insurance, Inc.

The contracts signed on March 2, 2001 include a "Contract to Buy" and two "Promissary Notes" between Krista L. Todd and Donald W. Sabo Jr. The Contract to buy included the sale of 1000 shares of stock for Sunshine Casualty Insurance, all furniture and office equipment, legal and financial responsibilities for the Corporation, all commission checks to be my property, etc. The Promissary note included figures for the actual sale of the agency and also a figure for repayment of Loans from Shareholders. Those contract are null and void and effective immediately I am rescinding my agreements with those contracts.

This decision for rescindment of contract is based on the finding of fraudulent actions taken. Those action to include: destroying of insured's insurance documents, holding insured's insurance applications longer than law permits, fraudulent documents concerning the Internal Revenue Service, Co-mingling of funds, and the non- replenishment of funds taken from the Corporation.

I am now hereby resigning as any Officer, Director, and Employee of Sunshine Casualty Insurance.

The one stock certificate that was assigned to me is now voided and all the corporate documents, paper work and payroll checks in your name will be returned to you immediately.

No action has been taken with any insurance company or vendor regarding the sale of the agency so you will not have to re-sign any agency or utility agreements for the corporation.
