The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is L. MONTY KANDEKORE, P.A.

ARTICLE II

DURATION AND BEGINNING OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence as of the filing of the Articles of Incorporation.

ARTICLE III

The corporation is organized for the purpose of practising law and transacting any and all lawful business.

CAPITAL STOCK

SHAREHOLDERS

This corporation shall not issue and no holder may sell or transfer his shares of capital stock to anyone other than an individual who is duly licensed to practice law.

ARTICLE VI

DISQUALIFICATION TO RENDER PROFESSIONAL SERVICES

No officer, shareholder, agent or employee of this corporation shall be permitted to continue as such upon becoming legally disqualified to practice law; in the event any shareholder becomes or is in any way legally disqualified or restricted or limited in his ability to practice law such shareholder's shares shall immediately become subject to purchase by this Corporation.
