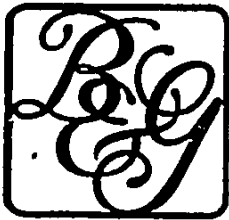

I. NAME

The name of the corporation is GULF SHORE MEDICAL GROUP, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.




