**ARTICLES OF INCORPORATION  
OF  
DR. FURCH - CONSULTING, INC.**

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I - Name**

The name of the corporation is **Dr. Furch - Consulting, Personal- & Management, Inc.**  
The principal place of business of the corporation is **2818 SW 49th Terrace, Cape Coral, FL 33914**. The mailing address of the corporation is **P.O. Box 354, Cape Coral, FL 33910**.

**ARTICLE II - Commencement and Duration**

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

**ARTICLE III - Purpose**

The corporation is organized for the purpose of transacting any and all lawful business.
