# ARTICLES OF INCORPORATION OF DR. FURCH - CONSULTING, INC.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

## **ARTICLE I - Name**

The name of the corporation is <u>Dr. Furch - Consulting, Personal- & Management, Inc.</u> The principal place of business of the corporation is 2818 SW 49th Terrace, Cape Coral, FL 33914. The mailing address of the corporation is P.O. Box 354, Cape Coral, FL 33910.
