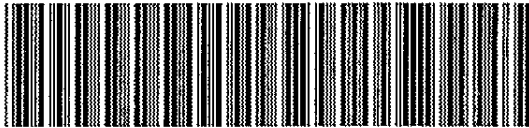

1. The name of the corporation is **JAYNE F. SCOTT MARKETING COMMUNICATIONS, INC.**


2. Dissolution was authorized on November 26, 2002 and is effective on December 31, 2002.
