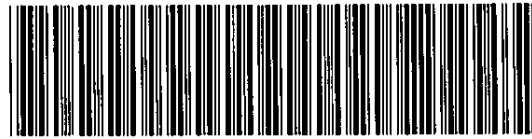

Pursuant to the provisions of Section 607.1006, Florida Statutes, Bridgefield Employers Insurance Company, a Florida for-profit corporation ("Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The address of the principal place of business of the Corporation as set forth at Article I, entitled "Name" is amended to be:

2310 Commerce Point Drive
Lakeland, FL 33801

The Corporation may establish and maintain the principal place of business of the Corporation at such other place within the State of Florida or elsewhere as may be determined from time to time by the Board of Directors.

2. Paragraph one of Article III, entitled "Capital Stock" is amended to read:

"The aggregate number of shares which the Corporation is authorized to issue is 25,000 shares of common stock. The common stock shall be of one class and shall have a par value of \$100 per share"

3. Pursuant to the referenced amendment, the Board of Directors, on the effective date thereof, authorizes the issuance of additional shares of the Corporation's common stock such that 25,000 shares of common stock with a par value of \$100 per share are issued and are outstanding to its sole shareholder, Summit Holding Southeast, Inc.

4. The date of the amendment's adoption is June 29, 2015.

5. The amendment was adopted by the Board of Directors of the Corporation, and duly approved by its sole shareholder.
