

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a For-Profit Corporation under the Florida Not for Profit Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

BOSCH MAINTENANCE AND MANAGEMENT, INC.

The address of the principal office of this Corporation shall be 3601 N.W. 35th Avenue, Miami, Florida 33142, and the mailing address of the Corporation shall be the same.

ARTICLE II

The period of duration of the corporation shall be perpetual.

ARTICLE III

The purpose for which the Corporation is organized is to engage in all lawful business activities permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV

The initial registered office of the Corporation shall be 11900 Biscayne Blvd., #310, North Miami, Florida 33181 and the name of the initial registered agent of the Corporation at that address shall be Kenneth J. Dorchak.

ARTICLE V




