## ARTICLES OF INCORPORATION OF ...AFFORDABLE PARALEGAL, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act. adopt the following Articles of Incorporation for such corporation:

#### ARTICLE 1

Name

The purpose or purposes for which the corporation is organized are to engage in any activities of business permitted under the laws of the State of Florida.

#### ARTICLE IV

#### **Shares**

NUMBER: The aggregate number of shares that the corporation shall have the authority to issue is 100 shares of Capital Stock with a par value of \$1.00 per share.

STATED CAPITAL: The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

DIVIDENDS: The holders of the outstanding capital stock shall be entitled to receive, when as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of capital stock of the corporation.

CLASSES OF STOCK: The shares of the corporation are not to be divided into classes.

SERIES: The corporation is not authorized to issue shares in series.

#### ARTICLE VIII

#### Shareholder Action

Three-fourth's (3/4th's) of the stockholders of the corporation shall be required for any shareholder actions.

#### ARTICLE IX

#### Power to Adopt, Amend, Alter, Change or Repel Articles

The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved be a stockholder's meeting, with not less than a three-forth (3/4ths) vote of the common stock.

The pre-emptive right of any holder is determined by the ratio of the authorized shares of common stock held by the holder of all common stock currently authorized.
