Pursuant to the requirements of Section 607.1105 of the Florida Corporation Act, the undersigned Joseph J. Nelson, President, of Jet Aviation Trading, Inc. and Michael J. Cirillo, President, of Schuylkill Acquisition Corp., hereby certify:
