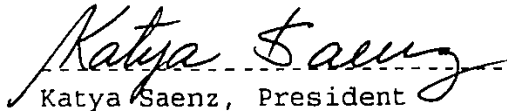
Article IX - Special Provision

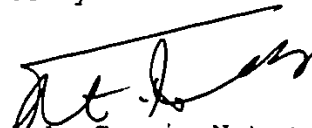

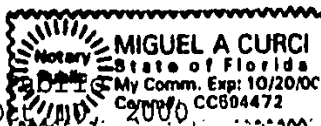
