

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I**

The name of the corporation is ALL FLORIDA HURRICANE SHUTTERS, INC.

**ARTICLE II**

This corporation shall have perpetual existence, commencing as of the time these ARTICLES are filed by the Department of State, Division of Corporations.

**ARTICLE III**

This corporation is formed for the purposes of planning, marketing servicing and installing of all types of hurricane shutters. It shall also be empowered to transact and perform any and all lawful businesses for which corporations may be authorized under the Laws of the State of Florida.

ARTICLE IX


The corporation reserves the right to amend or repeal any provisions contained in these ARTICLES or any amendment under the laws of the State of Florida.

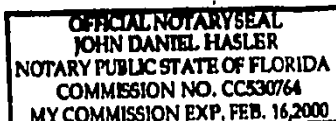
