whose addresses shall be the same as the principal address of the Corporation.

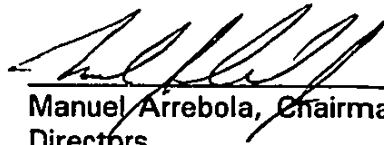
THIRD: The date of the adoption of this amendment is the 2 June 1997.
