THE UNDERSIGNED, acting as sole incorporator of Heather L. Higbee, P.A. under Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

Name

The name of the corporation is Heather L. Higbee, P.A.

**ARTICLE II**

Effective Date

The effective date of the corporation shall be June 2, 1997.

The Corporation shall have as its limited purpose, pursuant to Florida Statutes, Section 621.08, the rendering of professional legal services.


