ARTICLES OF INCORPORATION
OF
VECTOR TRADE CORPORATION

ARTICLE I - NAME

The name of this Corporation is VECTOR TRADE CORPORATION

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on May 23, 1997.
