### Article I - Name

The name of the corporation is MICHAEL T. CROWSON, INC., and the principal office and mailing address is 611 Druid Road East, Suite 717, Clearwater, Florida 34616.

### Article II - Duration

This corporation shall exist perpetually.

### Article III - Purpose
