THE UNDERSIGNED subscriber to these Articles of Incorporation hereby forms a corporation under the Laws of the State of Florida.

## ARTICLE 1

The name of this corporation is ROPY, INC.

#### ARTICLE II

This corporation shall have a perpetual existence.

The corporation is organized to engage in any business or purpose lawful under the Laws of the State of Florida.

## ARTICLE IV
