ARTICLE I - NAME

The name of the corporation is KOONTZ SERVICES, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles, or until such time as it shall be dissolved by law.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of engaging in any and all activities or business permitted under the laws of the State of Florida or United States.

ARTICLES IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of fifty cents (\$.50) par value Common stock, which shall be designated "common shares". Any and all such "common shares" shall be one class only.


