

ARTICLE I
Name of Corporation

The name of this corporation is LOPEZ EXECUTIVE SERVICES, INC.

ARTICLE II
Corporate Existence

This corporation shall have perpetual existence.

ARTICLE III
Purpose of Business

The purpose of this corporation is to engage in the transaction of any and all business permitted under the laws of the United States and of this state.






