#### ARTICLES OF INCORPORATION

# A Florida Corporation

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a Corporation for profit under the Laws of the State of Florida.

#### ARTICLE I

The name of the Corporation is : SUPERIOR STUCCO SYSTEMS INC.

### ARTICLE II

This Corporation is to exist perpetually unless dissolved in accordance with the Laws of the State of Florida.

## ARTICLE III
