The undersigned incorporates, each of whon is licensed or otherwist Attail ASSEE, FLORIDA authorized to practice the profession of law in the State of Florida, associate with the intention of forming a professional corporation in accordance with the Florida Professional Service corporation and Limited Liability compete act, and adopt the following articles of corporation for the corporation:

ARTICLE I

The name of the corporation is H. Steven Sussman, P.A.

ATRICLE II

The address of the corporation's principal; office is 1015 Belle Meade Island Drive, City of Miami, County of Dade, State of Florida, 33137. The initial registered agent of the corporation, located at that office H. Steven Sussman.

ARTICLE III

The period of the corporation duration shall be perpetual, that is, until dissolved by a vote of the shareholders provided in the articles.
