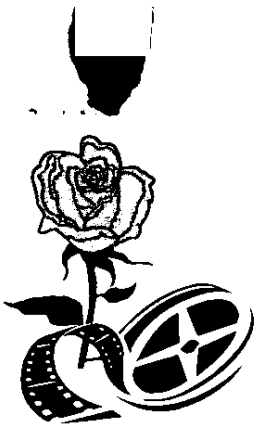


To Whom It May Concern:

Enclosed for filing with the state is a Corporation Reinstatement form for Floral Productions, Inc. I am the President/V.P./Director/Secretary of the corporation and have recently found that the corporation became inactive. The corporation was formed in 1997 and the original documents were filed by my former attorney, Thomas Harbert. Since the filing in 1997 I was under the impression that state paperwork was being filed on a timely manner and that my corporation continued to be active. I was devastated to find that my corporation became inactive and an administrative dissolution was filed in 1999. I never received any documentation in 1999 stating that my company was becoming inactive and did not have an opportunity to remedy the situation.

After doing research online and speaking with a Division of Corporations representative, I found that the reinstatement fee together with the annual fees total \$1,650.00. I am writing this letter in an effort to have the reinstatement fee waived. I am a small business owner and this current event has caused a hardship. I am enclosing a check in the amount of \$1,058.75 which represents the annual fees since 1999 through current year and the fee for a certificate of status. I am hopeful the reinstatement fee can be waived under these circumstances.
