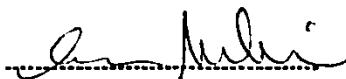

This corporation observe the rights to amend or repeal any provisions contained in these articles of Incorporation, or any rights conferred upon the shareholders is subject to this reservation.

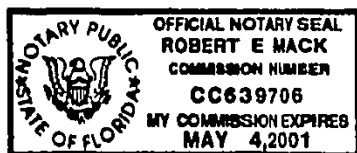
