
#### ARTICLE X - BYLAWS

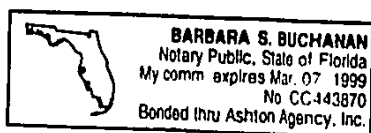


