The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is **HOLLER AND PARTNER, INC.** The principal place of business of the corporation is 4001 Tamiami Trail North, Suite 265, Naples, Florida 34103. The mailing address of the corporation is 4001 Tamiami Trail North, Suite 265, Naples, Florida 34103.

ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - Purpose

ARTICLE VIII - Officers

The initial officer(s) of the corporation shall be as follows:

ARTICLE IX - Indemnification

The corporation shall indemnify any officer or director, or person exercising powers and duties of an officer or director, to the full extent now or hereafter permitted by law.

ARTICLE X - Bylaws

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors.

ARTICLE XI - Pre-emptive Rights

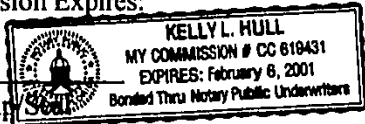
