

**ARTICLE I. CORPORATE NAME**

The name of this corporation is: A SENSIBLE SOLUTION - DME, INC., where the principal office is: 17861-D, Lake Carlton Drive, Lutz, FL 33549.

**ARTICLE II. NATURE OF BUSINESS AND POWERS.**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III. CAPITAL STOCK.**

The aggregate number of shares which this corporation shall have authority to issue is 100, shares of common stock having a NONE Par value per share.

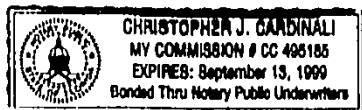


