Articles of Amendment to the Articles of Incorporation of Logue Enterprises, Inc.



Logue Enterprises, Inc., a Florida corporation, organized and existing under the laws of the State of Florida, hereby certifies as follows.

Pursuant to written action of all of the shareholders and members of the Board of Directors of the Corporation, in lieu of special meetings, which vote was sufficient for approval, the following resolution was adopted on December 20, 2002, amending the Articles of Incorporation, as follows:

RESOLVED, that the Corporation hereby amends and restates Article III of its Articles of Incorporation in its entirety to read as hereinafter set forth, and that the President of the Corporation shall execute and file with the Secretary of State of the State of Florida Articles of Amendment to the Corporation's Articles of Incorporation in accordance herewith:

"ARTICLE III - CAPITAL STOCK

The Corporation is authorized to issue One Thousand (1,000) shares of Ten Cents (\$0.10) par value common stock, which shall be designated "Common Stock", as follows:

One Hundred (100) shares of voting common stock, which shall be designated "Voting Common Stock"; and

Nine Hundred (900) shares of nonvoting common stock, which shall be designated "Nonvoting Common Stock".

Other than the difference in voting rights described above, all shares of Common Stock shall have the same rights and preferences."
