The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME. The name of the corporation is: BOULEVARD BRANDS INTERNATIONAL, INC

ARTICLE 2. DURATION. The duration of the corporation is perpetual.


ARTICLE 3. PURPOSE. The general purposes for which the corporation is organized are the following:
