ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. chapter 607 and all other applicable laws of the State of Florida, Feldman Corporation, by and through its authorized agent, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I. NAME

The name of the corporation ("Corporation") is Dream Flower, Corp.

ARTICLE II. ADDRESS OF CORPORATION
