The undersigned subscriber(s) to these Articles of Incorporation, competent to contract, hereby form a corporation under the laws of the State of Florida.

#### ARTICLE I. NAME

The name of the corporation is: F. & M. AVELLANEDA HARVESTING, INC.

# ARTICLE II. PURPOSES AND POWERS

The general nature of the business to be transacted by this corporation is: As a small business corporation, to engage in or transact any or all lawful activities or business permitted under the laws of the United States, State of Florida or any other state, country, territy or nation; to improve, manage, operate, sell, buy, mortgage, lease or otherwise acquire or dispose of any property, real or personal and take mortgages and assignments of mortgages upon the same; to make and obtain loans upon real estate, improved or unimproved and upon personal property, giving or taking evidences of indebtedness and securing the payment thereof by mortgage, trust deed, pledge or otherwise; to enter into contracts to buy or sell any property, real or personal; to buy and sell mortgages, trust deeds. contracts and evidence of indebtedness; to purchase or otherwise acquire, for the purpose of holding or disposing of the same, real and personal property of every kind and description, including the goodwill, stock, rights and property of any person, firm, association or corporation; paying for the same in cash, stock or bonds of this corporation; to draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, warrants, bonds, debentures and other negotiable or transferable instruments or obligations of the corporation, from time to time, for any of the objects or purposes of the corporation; to carry on all or any of its operations without restriction or limitation as to amount; to purchase, acquire, hold, own, mortgage, sell, convey or otherwise dispose of real and personal property of every class and description in any state, district, territory, colony, or foreign country.

To engage in any enterprise calculated or designed to be profitable to this corporation and in conformity with the laws of the State of Florida.

To conduct business in and have one or more offices in the State of Florida and in all other states and countries.

To purchase the corporate assets of any other corporation and engage in the same or other character of business.
