Pursuant to the provisions of Florida Statutes Section 607.1006, the Articles of Incorporation of NAPLES FIRE & SAFETY CORP., a Florida Corporation, are hereby amended as follows:

1. Article I of the Articles of Incorporation is hereby revoked and the following Article I is inserted in lieu thereof:

ARTICLE I - NAME

The name of the corporation is ABC FIRE EQUIPMENT CORPORATION.

2. The foregoing amendment was adopted on the 17<sup>th</sup> day of March, 1998.
