**THE UNDERSIGNED**, acting as sole incorporator of Hoyce Environmental Services, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name and Office**

The name of the corporation shall be **HOYCE ENVIRONMENTAL SERVICES, INC.**, and the corporate address shall be 999 West Lancaster, Suite 1, Orlando, Florida 32809.

**ARTICLE II**

**Duration**

The duration of the corporation is perpetual.

**ARTICLE III**

**General Purposes**

The purpose of the corporation is to engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

**ARTICLE IV**

**Shares**

The aggregate number of shares which the corporation shall have authority to issue is One Hundred (100.00) at consisting of a single class of common stock, \$5.00 par value per share.

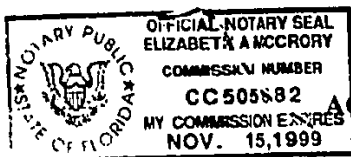
