The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: RANE'S SERVICE COMPANY.
The address of the principal office of this corporation shall be 13130 NE 38th Avenue, Anthony, Florida 32617, and the mailing address of the corporation shall be 13130 NE 38th Avenue, Anthony, Florida 32617.

ARTICLE II. DURATION

This corporation is to exist perpetually. The effective date of the corporation shall be June 1, 1997.

ARTICLE III. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having \$1.00 par value per share.

ARTICLE V. REGISTERED AGENT

The street address of the initial registered office of the corporation shall be, 13130 NE 38th Avenue, Anthony, Florida 32617, and the name of the initial registered agent of the corporation at that address is ELAINE D. TINSLEY.

ARTICLE VI. DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation. The initial Board of Directors shall consist of two directors. The names and addresses of the Directors constituting the initial Board of Directors are:

The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.

ARTICLE IX. SPECIAL PROVISION

It is the intent of the Incorporator that the corporation will qualify under section 1244 of the Internal Revenue Code and shall take all actions necessary to obtain and maintain its status as an S corporation.
