**ARTICLES OF INCORPORATION**  
**OF**

*The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associates herself to form a corporation under the State of Florida.*

**ARTICLE I**

**NAME:** *The name of this corporation is:*

**NEET RECORDS, INC.**

**ARTICLE II**

**PURPOSES AND POWERS:** *The general nature of business to be transacted by the corporation is as follows:*

- 1. The corporation may engage in any activity of business which is permitted under laws of the State of Florida.*
- 2. And in general, to carry on any other business whatsoever in connection with the forgoing or which is calculated, directly or indirectly, to promote the interest of the corporation or to enhance the value of its properties.*
- 3. And, further, to borrow or raise money for any purpose of the company, and to secure the same interest, or for other purposes, to mortgage all or part of the property corporal or incorporeal rights or franchise of this company now owned or hereafter acquired and to create, issue, draws, and accept and negotiate bonds and mortgages, bills of exchange, promissory notes or other obligations or negotiable instruments.*

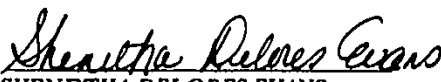

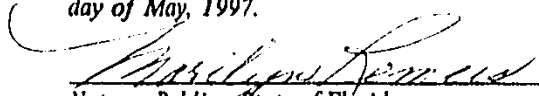
