ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act do hereby adopt the following articles of incorporation.

ARTICLE ONE

The name of the corporation is KEYWEST CORP.

The duration of the corporation shall be perpetual.

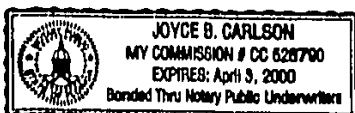
