ARTICLE ONE

The name of the corporation is **TRC ENTERPRISES, INC.** The principal address of the corporation is: 11152 Abercorn Extension, Savannah, Georgia 31419.

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**

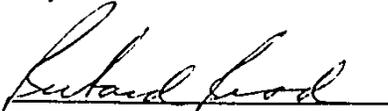
ARTICLE FIVE
