The undersigned incorporator hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

WEST VOLUSIA IMPOTENCY CENTER, INC.

and shall hereinafter be referred to as the "corporation". The business and mailing address of the corporation shall be Suite 5, 3951 South Nova Road, Port Orange, Florida 32127.

ARTICLE II

The time and date on which corporate existence of this corporation shall begin at 12:01 o'clock A.M. effective on May 27, 1997, and this corporation shall have a continuous and perpetual existence thereafter.

ARTICLE III

The general purpose for which the corporation is initially organized is the transaction of any and all lawful business for which corporation may be incorporated under Chapter 607, Florida Statutes, as amended.

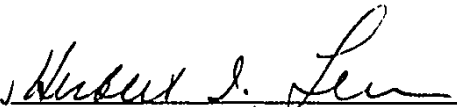

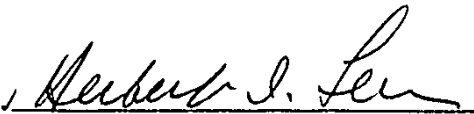
