The name of this Corporation is JOHNSON SERVICES GROUP, INC.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

ARTICLE VI - INITIAL BOARD OF DIRECTORS

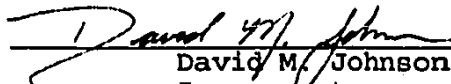

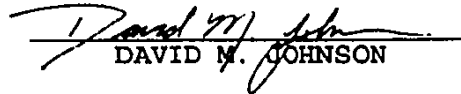

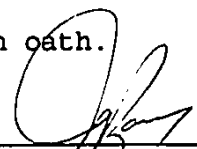
