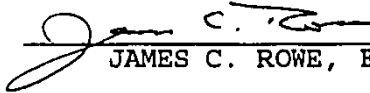

These Articles shall be effective upon filing with the Secretary of State for Florida.

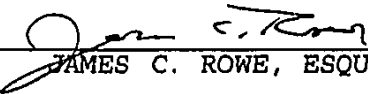
