ARTICLE I

NAME

The name of this corporation is:

COURTROOM GRAPHICS SERVICES, INC.

ARTICLE II

TERM OF CORPORATE EXISTENCE

This corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III

PERMITTED ACTIVITY

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may hereafter be amended.

ARTICLE IV

AUTHORIZED SHARES

This corporation is authorized to issue 1000 shares of One Dollars (\$1.00) par value common stock which shall be designated as "Common Shares."

## ARTICLE V

### PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

## ARTICLE VI

### REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation and initial place of business is 66 West Flagler Street, 7th Floor, Miami, Florida 33130. The initial Registered Agent is Albert J. George.

## ARTICLE VII

### DIRECTORS

The business of the corporation shall be managed by a Board of Directors consisting of not fewer than one person, the exact number to be determined from time to time in accordance with the By-Laws.

Expenses (including attorneys' fees) incurred in defending any claim action, suit or proceeding may be paid by the corporation in advance of the final disposition of such a proceeding.

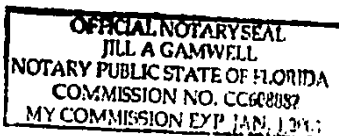
